### **What if my meeting overruns?**

For meetings lasting more than 60 minutes time will be charged at **£62.50 + VAT** per 15 minutes, or part thereof, and you shall be invoiced separately for this.

Yes. This will be charged at the same rate as if the meeting itself overruns and you will also be required to pay for this upfront (see above).
